### Squad Terms & Conditions

#### Squad

##### Squad Fees

Fees are billed monthly, as sessions continue through holidays, except for scheduled Easter and Christmas breaks. Billing is adjusted accordingly.

\*\*\*Fees are due for payment by the 7<sup>th</sup> day of each month. Fees not paid by the due date will incur a 15% late fee\*\*\*

- **Leopards & Mantas (Competition Squad):** Consistent training is required; no credits or adjustments will be made.
- **Skates Squads:** Holiday absences must be notified via email **before** billing to avoid full-month charges. Adjustments requested after billing will incur a \$20 administration fee.

Training schedules remain as consistent as possible. However, minor disruptions may occur during the competition season (October to April). Management will strive to minimise interruptions. For extended illness or extenuating circumstances, please speak with management.

##### Training Expectations

As training intensity increases, swimmers are expected to take responsibility for their performance and attendance. Squad swimmers affiliated with another swimming club are not permitted to train at Li'l Stingers Swim School in our squads.

##### Public Holidays

Squad sessions may be scheduled on public holidays at the coach's discretion.

##### Photography & Media Consent

Woree Sports & Aquatic Centre reserves the right to use images or videos taken during squad sessions for promotional purposes.

##### Supervision & Drop-Off Policy

Swimmers under 14 must be supervised outside of squad sessions. Drop-off and pick-up should occur no more than ten minutes before or after a session.

## **Practice Outside Squad Sessions**

Children enrolled in monthly billing can access the pool for practice at a discounted \$2 entry fee on non-session days. This policy does not apply to adults or casual squad swimmers.

## **Squad Swimming Code of Conduct**

### **Swimmer Agreement**

As a squad swimmer, I agree to:

#### **Commitment**

- Attend training regularly and arrive on time.
- Notify the coach if I cannot attend training or competitions.
- Give my best effort at every session.

#### **Behaviour**

- Respect coaches, teammates, officials and staff.
- Listen to instructions and accept feedback positively.
- Encourage and support my teammates.
- Use appropriate language and behaviour at all times.

Swimmers must not:

- Use inappropriate language or behaviour.
- Bully, exclude or disrespect teammates.
- Disrupt training sessions.
- Argue with coaches or officials.

#### **Training Standards**

- Bring required equipment to every session.
- Enter the water promptly and complete assigned sets.
- Stay in the pool until dismissed by the coach.
- Follow lane etiquette and pool safety rules.

#### **Competitions**

- Show good sportsmanship at all times.
  - Follow coach directions at meets.
  - Represent the squad positively.

## Parent/Guardian Agreement

As a squad parent/guardian, I agree to:

- Support my child's commitment and punctuality.
  - Encourage effort, improvement and enjoyment.
  - Allow coaches to coach (no sideline coaching).
  - Communicate respectfully with coaches and staff.
  - Raise concerns at appropriate times, not during training.
  - Help promote a positive and supportive team culture.

## Right to Refuse Entry or Terminate Squad Participation

Woree Sports and Aquatic Centre reserves the right, at its sole discretion, to refuse entry to, suspend, or permanently remove any swimmer or parent/guardian from the squad program at any time.

This may occur where behaviour or actions are considered to:

- Breach the Squad Code of Conduct
- Compromise the safety or wellbeing of swimmers, staff or patrons
- Disrupt training sessions, competitions, or facility operations
- Involve bullying, harassment, abusive or aggressive behaviour
- Damage property or bring the squad or facility into disrepute
- Fail to follow reasonable directions of coaches or staff

The Centre reserves the right to take immediate action without prior notice in serious cases.

Any decision made by Woree Sports and Aquatic Centre regarding refusal of entry, suspension, or termination of squad participation is **final** and not subject to review or appeal.

No refund will be provided for remaining sessions where removal occurs due to a breach of this agreement.
